- Creation of an account
- Requesting an offer
- Subscription to the newsletter
- Registration to a webinar/seminar/event/etc.
- Taking pictures, videos and minutes in the meetings and conferences organized by the WEEELABEX Organisation
- Recording webinars and conference calls
- Exchanging business cards

All personal data, collected by the WEEELABEX Organisation, are therefore explicitly and freely provided by you.

4. How do we process personal data?

We will use your personal information, only where we have a lawful basis for processing.

The WEEELABEX Organization can use your personal data for the following purposes:

- Fulfillment of a contract with the WEEELABEX Organization
- Communicating with its members and stakeholders
- Sending newsletters
- Confirmation of the subscription and follow-up communications after a meeting/workshop/conference
- Invoicing

We do not track nor collect information from individual visitors of our websites and social media (no use of cookies that track personal information). But we do use Google Analytics to analyse the trends in websites' visit (country, language, the pages visited etc.) in order to provide better communication services. The collected trends are only shared internally within the company.
